EMERGENCY ORDER # 7

Pursuant to the authority in TCA 58-8-104, 1, Robertson County Mayor William A. Vogle, declared a State of Local Emergency on the 19th day of March, 2020, (Order #1) and by Emergency Order #2 issued on March 25, 2020, granting to the County Mayor certain powers as allowed under TCA 58-2-110. Emergency Order #3 issued by this office was effective March 28, 2020. Emergency Order #4 issued by this office was effective April 4, 2020, Emergency Order #5 issued by this office was effective April 11, 2020, and Emergency Order #6 issued by this office was effective April 18, 2020. This declaration gives political subdivisions of government, both City and County, the ability to waive procedures relative to "performance of public works and taking whatever prudent action is necessary to ensure the health, safety and welfare of the community."

Pursuant to those same statutes I hereby amend Emergency Order #1, Emergency Order #2, Emergency Order #3, Emergency Order # 4, Emergency Order #5, and Emergency Order #6 as follows:


1. All provisions of prior Emergency Orders not altered or amended herein shall remain in full force and effect according to their terms.
2. If any provision, sentence, clause, phrase, or word, of this Order or any application of it to any individual, business, or circumstance is held to be invalid by a decision of a court of competent jurisdiction, then such decision shall not affect the validity of the remaining portions or applications of this Order.
3. The mandates in each ORDER are not applicable to those entities identified by their work or services as critical infrastructure industry(s) as defined by the Department of Homeland Security, such as healthcare services, pharmaceutical and food supply. This ORDER does not apply to activities necessary to maintain continuity of operations of critical infrastructure sectors, as outlined at <https://wwwv.cisa.fov/identifying-critical-infrastructure-during-covid-19>.


4. Robertson County acknowledges the Guidelines issued by Governor Bill Lee as pertains to the proposed re-opening of restaurants on Monday, April 27, 2020 and the re-opening of retail business on Wednesday, April 29, 2020, with recommended best practices for such re-openings as set forth in that document from the Governor's office issued on Friday, April 24, 2020, attached hereto as Exhibit "A", (referred to as herein as "the Guidelines").
5. Accordingly, the Robertson County Mayor hereby adopts those provisions as may be applicable to such re-openings from the Governor's Office as likewise attached hereto.

This Emergency Executive Order shall be effective and enforceable at 12:01 am Central Daylight Time, on Saturday, April 25, 2020 and shall remain in effect until the passing of seven (7) days, at which time the same will be extended, amended or otherwise addressed.

This Order shall be effective upon issuance, as it is necessary to ensure the health, safety and welfare of the community.
